Mayor McBride called the meeting to order at 5:30 pm, the roll was recorded as such:

2017:187 RESOLUTION REQUESTING THE CAMDEN COUNTY IMPROVEMENT AUTHORITY REALLOCATE FY 2015 (YEAR 37) COMMUNITY DEVELOPMENT BLOCK GRANT FUNDING FOR USE IN THE LEND-A-HAND PROGRAM

WHEREAS, the Township of Pennsauken completed repaving of local streets in income-eligible neighborhoods in 2015; and

WHEREAS, there remains \$40,503.61 of unused funding in Year 37 for use in local street repaving; and

WHEREAS, the amount of remaining funding is insufficient for use in a street repaving project; and

WHEREAS, there is need for additional funding in the Lend-A-Hand Program in order to provide assistance to low and moderate income eligible homeowners for home improvements; and

WHEREAS, the Township of Pennsauken proposes to reallocate \$40,503.61 of unused local street repaving funding to the Lend-A-Hand Program; and

WHEREAS, a public hearing was duly advertised and conducted on June 28, 2017 inviting public comments on the proposed reallocation; and

WHEREAS, no adverse comments were received from the public.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Pennsauken, County of Camden and State of New Jersey that the

Township of Pennsauken hereby requests that \$40,503.61 of unused CDBG FY 2015 (Year 37) funding be reallocated to the Lend-A-Hand Program.

Administrator Kneib commented that this will allow for up to \$14,000 of improvements instead of the previous amount of \$5,000

ORDINANCES – SECOND READING/PUBLIC HEARING (PUBLIC MAY COMMENT)

2017:09 AN ORDINANCE TO AMEND THE CODE OF THE TOWNSHIP OF PENNSAUKEN, CHAPTER 243 THEREOF, ENTITLED “PROPERTY MAINTENANCE”

BE IT ORDAINED by the Township Committee of the Township of Pennsauken, in the County of Camden and the State of New Jersey as follows:

Section 1. The title of the Chapter 243 be amended to read: Property Maintenance Code and Smoke Detector Inspections (*Italics added for showing of changes only*)

Section 2. Article V be added to Chapter 243

Section 3. Article V Shall Read: Smoke Detectors and Carbon Monoxide Detectors

Section 243-17 shall read: Certificate of smoke detector compliance required.

Before any R-3 or R-4 residential unit is sold, leased or otherwise subject to change of occupancy for residential purposes, the owner shall obtain a certificate of smoke detector and carbon monoxide alarm compliance (CSDCMAC) evidencing compliance with N.J.A.C. 5:18-4.19 from the Bureau of Fire Prevention.

Section 243-18 shall read: Application; fee.

The owner or the authorized agent of the owner shall apply for a CSDCMAC on a form provided by the Bureau of Fire Prevention. The application shall be accompanied by a fee, which is outlined below, made payable to the Township of Pennsauken, in accordance with N.J.A.C. 5:18-2.8.

- A. Requests for CSDCMAC received more than 10 days prior to the inspection date: \$50
- B. Requests for CSDCMAC received 4 to 10 days prior to the inspection date: \$85.
- C. Requests for CSDCMAC received fewer than 4 days prior to the inspection date: \$140.
- D. A reinspection fee of \$50 shall be charged for any noncompliance on the first inspection.

Section 243-19 shall read: Nontransferability.

A CSDC shall not be transferable. If the change of occupancy specified in the application for a CSDC does not occur within 6 months, a new application shall be required.

Section 243-20 shall read: Inspection required; certification in lieu of inspection.

No CSDCMAC shall be issued until inspection of the structure indicates compliance with N.J.A.C. 5:70-4.9.

Section 243-21 shall read: location of smoke detectors in one and two-family dwellings

A. Smoke detectors for one and two-family dwellings shall be subject to the requirements of N.J.A.C. 5:18-2.20 and shall be located as follows:

- (1) On each level of the premises, including the basement and walk-up attic; and

(2) All residential sleeping areas with the Township of Pennsauken shall have at least one fully operable smoke detector located in each sleeping area. All such residential sleeping areas enclosed by a door or otherwise shall in addition, have at least one fully operable smoke detector located outside of each sleeping area within 10 feet of such sleeping area. Installation of the smoke detectors shall be in accordance with the manufacturer's recommendations and the National Fire Safety Code, Township ordinances or any applicable statute or ordinance. Additionally, a carbon monoxide detector(s) shall be installed within 10 feet of every sleeping area, meeting the requirements of UL Standard 2034; provided, however that no carbon monoxide alarm shall be required in any building that does not contain any fuel-burning appliances and does not have an attached garage.

B. The smoke detector required in Subsection A above shall be located in accordance with NFPA 74-1984, incorporated herein by reference, and maintained in working order.

C. The detectors shall not be required to be interconnected.

Section 243-22 shall read: Power source.

A. Smoke detectors may be battery powered where no hard wired Alternating-current-powered (AC/DC) type are present and shall be listed in accordance with ANSI/UL217.

B. AC/DC smoke detectors shall be accepted as meeting the requirements of this section.

Section 243-23 shall read: Installation prior to inspection; fee; reinspection.

Smoke detectors required to be installed in accordance with N.J.A.C. 5:70-4.19 must be installed prior to the scheduled inspection. A fee of \$50 made payable to the Township of Pennsauken will be charged and must be paid prior to any required reinspection which was required due to the property owner's and/or agent's lack of compliance with the requirements of this article.

Administrator Kneib stated this moves the smoke detector inspections to be done by Code Enforcement.

2017:188 RESOLUTION APPROVING THE SHARED SERVICES AGREEMENT WITH THE TOWNSHIP OF CHERRY HILL FOR THE MILLING AND REPAVING OF WISTERIA AVENUE

WHEREAS, Wisteria Avenue is a dedicated street that lies on the municipal boundary between the Townships of Pennsauken and Cherry Hill; and

WHEREAS, both Pennsauken and Cherry Hill are in agreement that the road is in need of repaving; and

WHEREAS, on behalf of the residents of both municipalities that reside on Wisteria Avenue, Pennsauken and Cherry Hill have agreed to work cooperatively to accomplish the repaving of Wisteria Avenue; and

WHEREAS, both Pennsauken and Cherry Hill are in agreement that Cherry Hill Township will assume lead agency responsibilities; and

WHEREAS, Pennsauken Township agrees to reimburse Cherry Hill Township for one half of the total cost of the repaving project; and

WHEREAS, Pennsauken and Cherry Hill are authorized pursuant to the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1, et seq. to enter into a shared service agreement with any other local unit to provide or receive any service that each local unit could perform on its own.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Pennsauken, County of Camden and State of New Jersey that the Shared Services Agreement with the Township of Cherry Hill for the milling and repaving of Wisteria Avenue included as an Attachment to this Resolution is hereby approved.

BE IT FURTHER RESOLVED that the Township Administrator is hereby authorized to execute said Shared Services Agreement on behalf of Pennsauken Township.

BE IT FURTHER RESOLVED that a certified copy of this Resolution be forwarded to Honorable Mayor Charles Cahn, Cherry Hill Township and to the Director of Engineering for Cherry Hill Township and that a fully executed copy of the Shared Services Agreement be forwarded to the Pennsauken Township Clerk to be maintained on file until project closeout.

Administrator Kneib explained this will be shared with Cherry Hill, who received a lower estimate than Pennsauken (Pennsauken saved \$5,000)

Ellyn McMullen of Palace Court questioned if this will be for all of Wisteria

Committeeman Taylor commented from Chapel Avenue to the dead end.


