

**RESOLUTION AWARDING BID 22-15 THE PURCHASE OF MOBILE STAGE AND  
OPTIONAL ACCESSORIES  
(PROGRESSIVE PRODUCTS, INC)**

**WHEREAS**, Township Committee of the Township of Pennsauken has determined purchase of Mobile Stage and Optional Accessories for the use for Township of Pennsauken same being more particularly described in specification which are on file in the Office of the Township Finance Department and available for public inspection during regular business hours: and it appearing that the cost of the aforementioned renovation will be paid with municipal funds and will exceed \$44,000 in a fiscal year: and

**WHEREAS**, N.J.S.A 40A: 11-4 states that a contract, the cost of which will exceed \$44,000 in the fiscal year, shall be awarded only after public advertising for bids and bidding therefore: and

**WHEREAS**, there has been public advertisement for bids, and the Township Purchasing Agent has received and opened bids on June 1<sup>st</sup>, 2022 at 11:30am am for the purpose of awarding the purchase of Mobile Stage and Optional Accessories has advised the Township Committee that a certain entity is the lowest, qualified, responsible bidder for said purchase and has recommended that the Township Committee award said purchase or reject the bids within sixty (60) days as required by N.J.S.A 40A:11-24: and

**WHEREAS**, the Chief Financial Officer of the Township of Pennsauken, as required by N.J.A.C 5:30-1 has certified that there are sufficient funds available for the purchase Mobile Stage and Optional Accessories and entity said certification being attached hereto and made a part hereof: Budget Account: do not exceed \$116,346.00; and

**WHEREAS**, that after review and evaluation Progressive Products Corp, 3305 Airport Circle, Pittsburg, KS 66762 is hereby accepted as the lowest responsible bid; and

**NOW THEREFORE, BE IT RESOLVED** by the Township Committee of Township of Pennsauken, County of Camden, State of New Jersey, as follows:

1. The Township Committee, based upon the aforementioned certificate, hereby declares that there are sufficient funds available for the aforesaid purpose, as is evidenced by the attached Certification of Availability of Funds
2. That the Township Committee, for the aforementioned reasons, hereby declares that Progressive Products Corp, 3305 Airport Circle, Pittsburg, KS 66762 is the lowest, qualified responsible bidder for the of the purchase of Mobile Stage and Optional Accessories and hereby authorized an award in the amount of do not exceed \$116,346.00
